| | 3.2 | Wanda McKinnon advised that the AO4 Team Leader position in Maryborough has been filled permanently. | |
| 4 | 4.1 Workload Management | There were no workload management issues from Recruitment, Payroll or Finance. Payroll is utilising central teams in Brisbane to reduce overtime and monitoring duty of care to all staff members. Storeperson issue for Supply as above – does not have enough casuals to provide leave relief. Staff once again reminded to complete the workload management tool form if there are any issues and unless these are lodged they cannot be actioned. Ron Fossen supported the use of this tool. | |
| | 4.2 Equity & Diversity | There were no Equity and Diversity issues from any of the services. | |
| | 4.3 Leave Relief | No issues for recruitment or payroll. Finance were not represented at the meeting. Michelle Kennedy explained the SSP B33 Leave Relief process. As stated above Supply are having difficulties with leave relief backfill and do not have enough casual employees. It was confirmed that SSP can also draw upon the District staff if required. | |

| | 5.1 | It was confirmed that SSP is now backfilling vacant leave positions and the process was clear surrounding the B33 SSP Leave Relief process. Payroll did not have any issues and Finance were unavailable. Recruitment advised that both vacant AO3 positions have been advertised and there should be an outcome in the next couple of weeks. | |
| | 5.2 | Wanda advised that the new Payroll model is going well – staff have more ownership and now know who they are paying. All sites are live and there has been a reshuffle of staff members to allow for the relevant training. Steve raised the point that he would like SSP to be managed by the local Payroll offices Wanda advised that the Payroll Line Managers Booklet has been sent out to Line Managers confirming which teams are managing their particular areas and it also contains relevant contact information. | |

Discussions were entered into in relation to SSP services all moving into the new Cancer Care building in Bundaberg – estimated prospective 2 year projection.
