

Application Process

Medical Aids Subsidy Scheme (MASS) Static Shower Chair/Stool and Static Over Toilet Aid Trial

This application process is to provide a guide for applying for the following: Static Shower Chair/Shower Stool/Over Toilet Aid under the Static Bathing and Toileting Aids (BTA) Trial.

As per the [Static BTA Trial Guidelines supplement](#), selection of item/s requested under this trial should be chosen from the MASS Static Bathing and Toileting Aids (BTA) Standing Offer Arrangement (SOA) Weblist available on the MASS Website

All applications must be submitted via MASS-eApply and include the [MASS 20 Static BTA Trial Supplement Form](#) available on the MASS website.

If applying for both a bathing aid and a toileting aid, only one MASS-eApply application needs to be submitted.

Application Process through MASS-eApply

1. Login to MASS-eApply and go to the form vault: <https://forms.health.qld.gov.au/#/vault>
2. Start a **Daily Living Aids and Mobility Equipment** application
3. Complete form from Applicant Search up-to Prescriber Details as usual
4. Equipment Selection page – Under “Please select one or more equipment categories:”
 - a. Select “Bathing and/or Toileting Aids”.
 - b. Select “Bath Transfer Bench” for Static Shower Chair or Static Shower Stool.
 - c. Select “Static or 3-in-1 Commode” for Static Over Toilet Aid.
 - d. Note: Both categories can be selected.
