A live birth following a termination of pregnancy is not a botched abortion, and any suggestion of that is insensitive and cruel.

Deciding to end a pregnancy is a personal decision, which can be made for a range of reasons.

Whatever your circumstances, a healthcare provider or counselling service, and sometimes your GP, can provide you with information and advice to help you understand your rights and the options available to you, including the types of procedure, cost, and services near you.

Background - not for attribution:

Signs of life following a termination of pregnancy does not mean the termination was unsuccessful.

There were no amendments to the *Births, Deaths and Marriages Registration Act 2003* as a result of the *Termination of Pregnancy Act 2018* (the Act) being introduced on 3 December 2018. This means that the birth of any baby born in Queensland, which includes a stillborn child, must be registered as a 'birth' under the Act. It also means that the delivery of a foetus, after a termination of pregnancy with any signs of life, must have the birth registered as well as the death.

The Queensland Clinical Guideline for termination of pregnancy follows the Australian Government's definition of a live birth and outlines sign of life to include: beating of the heart, pulsation of the umbilical cord, breath efforts, definite movement of the voluntary muscles, any other evidence of life.

QUEENSLAND HEALTH'S CLINICAL GUIDELINES FOR ABORTION STATE:

'IF [DURING AN ABORTION] A LIVE BIRTH OCCURS... DO NOT PROVIDE LIFE SUSTAINING TREATMENT... DOCUMENT THE TIME AND DATE OF DEATH. IN 2016 IN VICTORIA, 33 OUT OF THE 310 BABIES ABORTED AFTER 20 WEEKS GESTATION WERE BORN ALIVE.

ALSO IN VICTORIA, BABIES BORN ALIVE DURING LATE-TERM ABORTIONS, THAT SUBSEQUENTLY DIE, ARE RECORDED AS NEONATAL DEATHS, NOT ABORTED BABIES.

BETWEEN 2005 AND 2015, 204 BABIES WERE BORN ALIVE AS A RESULT OF BOTCHED ABORTIONS IN QUEENSLAND.

Queensland Health is exploring ways to improve access to termination of pregnancy services for women in country Queensland.

Two years after passing the Termination of Pregnancy Act 2018, we're focusing on ensuring women in rural and remote communities know what their legal rights are, what is involved if they choose termination, and how to access services.

Many of our 16 Hospital and Health Services have referral pathways in place and are looking at alternative ways of delivering services, including by telehealth and by establishing partnerships with private providers, like Marie Stopes Australia.

This includes more than \$413,000 in grant funding that was provided to Marie Stopes International last year as part of the COVID-19 Immediate Support Measure grants. This additional funding will mean continuity of care for communities in Central Queensland, Rockhampton and Townsville.

This is in addition to the \$1.65 million Service Agreement in place with Marie Stopes International over the 1 January 2020 to 21 December 2022 period.

We met with consumer representatives, clinicians, service providers and government executives in Brisbane to discuss access issues and develop solutions.

Priority access is being given to women with complex needs, women who are marginalised because of discrimination and disadvantage, young women and women with a health care card and no financial means for a private provider option.

Financial assistance may also be available through the PTSS for women who need to travel for services not available locally.

- The Department of Health has a Service Agreement with Marie Stopes International (Marie Stopes) to provide \$1.65 million for financial support over the period 1 January 2020 to 31 December 2022. The Department had a previous Service Agreement with Marie Stopes for funding of \$1.65 million for the term 1 December 2016 to 31 December 2019. The funding is provided for lease and travel costs to support the continued operation of Marie Stopes's clinics in Rockhampton and Townsville.
