NOTICE OF SUSPENSION OF PROCEEDINGS

Mental Health Act (MHA) 2016, Section 91, 93, 616, 617

- The Chief Psychiatrist can direct a psychiatrist report for a person charged with a serious offence:
- at the request of the person, or another person authorised to make the request on their behalf, or

on the Chief Psychiatrist's own initiative.

- If the Chief Psychiatrist directs a psychiatrist report, the proceedings for the serious offence and any associated offence to which the direction relates is suspended.
- The Chief Psychiatrist must give written notice of the suspension to the Chief Executive (Justice).

 The Chief Executive (Justice) must give a copy of the notice to:

 the registrar of the court in which the proceeding has been brought
- - the prosecuting authority for the offence, and
 - If the person is a child within the meaning of the Youth Justice Act 1992- the Chief Executive (Youth Justice).
