I write in response to your request for approval of the Quarantine Accommodation & Training Facility Management Plan (the Sunshine Coast Hub Plan) for the proposed NRL Hub located at the Novotel Sunshine Coast Resort facility, 270 Ocean Drive, Twin Waters, Sunshine Coast QLD 4564 (Novotel Twin Waters Resort) and the identified training facilities located at the Novotel Twin Waters Resort and Sunshine Coast Falcons (Sunshine Coast Stadium).

I understand your request is to relocate 12 NRL teams (players, officials, and essential support staff) from declared COVID-19 hotspots in New South Wales in order to continue the 2021 NRL Season (NRL Personnel). The NRL Personnel proposed to be based at the Novotel Twin Waters Resort in accordance with the Sunshine Coast Hub Plan from 14 July 2021 are:

- 1. Newcastle Knights
- 2. Penrith Panthers
- 3. Sydney Roosters
- 4. Manly Warringah Sea Eagles

As you are aware, the New South Wales (NSW) Government is currently managing an outbreak of COVID-19 within NSW including locations such as Greater Sydney, Wollongong and Central Coast. Queensland has subsequently declared the Local Government Areas for these locations as hotspots under the *Declared Hotspots Direction*.

I refer to the exemption I granted to these NRL teams on 14 July 2021 to enter Queensland from a declared COVID-19 hotspot, pending the further assessment and approval of the Sunshine Coast Hub Plan.

In order to continue to facilitate this exemption and the relocation to Queensland, I have assessed and approve the Sunshine Coast Plan, subject to the following conditions:

- 1. Implement and comply with the Sunshine Coast Plan.
- 2. For absolute clarity, this approval permits the NRL Personnel to access the identified training facilities and the match-day venues during the 14-day quarantine period.

- 3. The NRL has provided a full list of the names, residential addresses, date of birth, contact phone numbers and email addresses of NRL Personnel who will be entering Queensland as part of the Sunshine Coast Hub Plan.
 - a. Should there be any change to the identified individuals, the NRL must immediately email an updated list (including latest COVID-19 test results) to COVID-19.Compliance@health.qld.gov.au.
- 4. All players, officials or essential support staff are to continue to monitor the list of interstate exposure venues and notify COVID-19.compliance@health.qld.gov.au immediately if any of the NRL Personnel have been at these venues at the nominated day and time.
- 5. <u>All transportation</u> of the teams within Queensland is to be undertaken using an Endorsed Transport Provider.
 - a. For further information, go to https://www.qld.gov.au/health/conditions/health-alerts/coronavirus-covid-19/current-status/public-health-directions/covid-19-testing-for-quarantine-facility-workers/endorsed-transport-providers.
- 6. All NRL Personnel must complete a Queensland Border Declaration Pass prior to entering Queensland. For further information, go to https://www.qld.gov.au/border-pass.
- 7. There must be no close contact between NRL Personnel and non-quarantined persons including, but not limited to, members of the public, media, transport providers, training facility staff and Accommodation Hub staff.
 - a. Access to training facilities must have a similar set-up as the Accommodation Hub with established red and green zones and processes.
- 8. In the event that NRL Personnel are required to leave the Sunshine Coast Hub for medical treatment or testing, the ambulance service and receiving hospital are to be notified in advance that the Personnel is in quarantine. Prior to leaving the hub the public health unit is to be informed at EOC SCPHU@health.gld.gov.au.
- 9. A schedule of all training and match-day venue movements must be developed in accordance with the Accommodation Hub and these venues and if requested supplied to the public health unit at EOC SCPHU@health.gld.gov.au.
- 10. If any NRL Personnel or Accommodation Hub staff develops symptoms related to COVID-19, they must immediately isolate until they receive a negative COVID-19 test result.
- 11. The NRL are responsible for ensuring all NRL Personnel comply with the Sunshine Coast Hub Plan including, but not limited to:
 - a. adhering to all schedules developed and implemented by the Accommodation Hub staff such as mealtimes, access to transition zones and access to entry/exits.
 - b. ensuring meal areas, common areas, and rooms are all cleaned and disinfected between use.
 - c. cleaning of any spills and breakages.
 - d. Strict adherence to the processes for accessing and staying within:
 - i. Red zones
 - ii. Transition Zones
 - iii. Green Zones
- 12. At a minimum, there must be 24/7 security positioned at each entry and exit point to the Accommodation Hub for the duration of the quarantine period.
- 13. The NRL must work with the Accommodation Hub staff to develop and implement scheduled and staged mealtimes to ensure all NRL Personnel are not in the meal area at the same time.

- a. It is suggested this is in dedicated "seatings" of 45 minutes with adequate time scheduled between seatings to ensure the refill of food by Accommodation Hub staff can occur without any NRL Personnel in the area.
- 14. All Accommodation Hub areas and training facilities (including gymnasiums) that are accessible to the NRL Personnel are to be exclusive use.
 - a. Exclusive use means for the sole purpose of the NRL Personnel for the duration of the 14-day quarantine period. There must be no access by any other persons to these areas other than in an emergency.
- 15. For absolute clarity, the laundry of personal items conducted by NRL Personnel is only permitted in the red zone. All laundry of items outside the red zone must follow the laundry process outlined below and in the Sunshine Coast Hub Plan.
- 16. Laundry and linen must be laundered by a Laundry which meets the Australian Standards (AS/NZS 4146:2000 Laundry Practice) for commercial laundries.
- 17. No cleaning of accommodation rooms, dining areas, training facilities or any other facility or location is permitted by Accommodation Hub staff or any other cleaning contractor throughout the duration of the quarantine period, the quarantine period being up to and including the return of negative day 12 COVID-19 test results for all NRL Personnel and all Accommodation Hub staff. Cleaning must be in accordance with requirements as outlined in the Queensland Health COVID-19 cleaning, disinfection and waste management policy.
 - a. NRL Personnel must clean all equipment prior to and on completion of use at training facilities, including designated training facilities at the Accommodation Hub and any other external training facility.
- 18. If Accommodation Hub staff enter a Red Zone or there is an interaction with a NRL Personnel, then the Public Health Unit must also be notified of the incident.
- 19. NRL is responsible for ensuring any private members of the public who are owner-occupiers of units and/or property at the Novotel Twin Waters Resort are not permitted entry or access to the Accommodation Hub for the duration of the quarantine period. The Public Health Unit must be notified immediately of any breach of this condition.
- 20. Clarify that when wheelie bins are to be positioned in the Transition Zones for the collection of waste, all high touch points on the bins are to be thoroughly cleaned prior to the wheelie bins being moved by the Accommodation Hub Staff.
- 21. In the event that an individual reports symptoms, the individual is not to be sent offsite for assessment, without first consulting with the Public Health Unit.
- 22. All individuals must adhere to PPE requirements in accordance with the *Mandatory Face Masks Direction* (No. 2), effective from 22 March 2021 or its successor including:
 - i. A person at a **Queensland airport** must:
 - 1. carry a face mask at all times; and
 - 2. wear a *face mask* in all areas of a *Queensland airport*, including a passenger waiting area, at all times when at the airport; and
 - 3. wear a **face mask** where required to do so in accordance with any other Public Health Directions in effect under section 362B of the *Public Health Act 2005*.

Note: A face mask must be worn in all indoor and outdoor areas at a Queensland airport.

23. The Restrictions for Impacted Areas Direction (No. 8) took effect from 3 July 2021 and includes the Sunshine Coast Local Government Areas (LGA) as an impacted area. Noting the locations proposed by NRL for accommodation, training and matches are located within this LGA, all individuals must comply with requirements stated in the Restrictions for Impacted Areas Direction (No. 8) until revoked, including:

- a. All persons who are in or have been in an impacted area at any time from 1.00am on 29 June 2021 must carry a face mask at all times; and wear a face mask covering the nose and mouth at all times if they are in an indoor space or an outdoor space. Noting that these requirements do not apply to a person in an outdoor space, including a workplace, if the person can maintain physical distance from people who are not members of their household; or to a person in an indoor space that is a residence, temporary accommodation.
- b. For professional sporting codes, elite sport and elite athletes, occupant density requirements do not apply on the field of play, however physical distancing applies off the field of play to the extent possible.
- 24. All NRL Personnel and Accommodation Hub staff are required to comply with requirements outlined in the *Restrictions on Businesses, Activities and Undertaking* (No. 21) or its successor.
- 25. The NRL, NRL Personnel and Accommodation Hub staff must maintain ongoing communications with and follow any Direction given by the local Public Health Unit, including an Emergency Officer (General) within designated timeframes.
- 26. Strict adherence is required by all NRL Personnel in completing and submitting a *Daily Health Confirmation* in accordance with the Player & Club Protocol. Strict adherence is required by all Players and Club Officials in completing and submitting a *Daily Whereabouts Confirmation* in accordance with the Player & Club Protocol.
- 27. All teams within the NRL 2021 Season that are not within a Hub arrangement must continue to operate under the Level 4 Apollo Match-Day Protocol and the Level 4 Apollo Player and Club Protocol 2021.
- 28. NRL must provide the name and contact details of a designated NRL Personnel member responsible for actively monitoring compliance with the Sunshine Coast Hub Plan.
- 29. Any breach of the requirements to the Sunshine Coast Hub Plan, unintentional or otherwise, must be immediately reported to Sunshine Coast Public Health Unit.
- 30. All COVID-19 test results be provided to Queensland Health via Compliance@health.qld.gov.au. Test results are to be provided to Queensland Health within 8 hours of their receipt by the NRL.
- 31. Upon confirmation of Day 12 COVID-19 test result being negative for all Accommodation Hub staff and NRL Personnel, the Accommodation Hub may return to delivering normal hotel services to the NRL Personnel.
 - a. There must be no hotel services provided to any other persons until the 14-day guarantine has been completed.
- 32. The Queensland Health contact person for the Sunshine Coast Plan is:
 - a. Greg Bennett, s @health.qld.gov.au.
- 33. Queensland Police Service are to be immediately informed of all breaches of quarantine to Andrew Massingham at opensions <a h
- 34. At all times physical distancing must be maintained as much as practicable.
- 35. At all times hand and respiratory hygiene are to be encouraged
- 36. An amended Sunshine Coast Hub Plan that incorporates the conditions of this approval must be provided to Compliance@health.qld.gov.au within 3 business days of this approval.
- 37. Where inconsistencies exist between the Sunshine Coast Hub Plan and the Chief Health Officer approved conditions, the approved conditions take precedence.

This approval does not include media and broadcast personnel who are intending to arrive in Queensland from a declared COVID-19 hotspot for the 2021 NRL Season. Any exemption request will be considered as a separate application and assessment to this approval.

Please note that this approval may be revoked or varied if Queensland, New South Wales and/or Australia experiences an increasing number of COVID-19 cases, there is an outbreak(s) of COVID-19 or further COVID-19 hotspots are declared.

Exemptions

I, Dr Jeannette Young, Queensland Chief Health Officer, grant the following exemptions from the Public Health Directions to National Rugby League. These exemptions only apply to the extent that a person is operating in their capacity as part of the NRL 2021 Season. If a person is undertaking normal activities in daily life, then they must comply with the requirements of the Public Health Directions.

Table of exemptions from the Public Health Directions for National Rugby League as at 14 July 2021

Exemptions

I, Dr Jeannette Young, Queensland Chief Health Officer, grant the following exemptions from the Public Health Directions to National Rugby League. These exemptions only apply to the extent that a person is operating in their capacity as part of the NRL 2021 Season. If a person is undertaking normal activities in daily life, then they must comply with the requirements of the Public Health Directions.

Direction	Requirement	Exemption
Border restrictions Direction (no.26) or its successor Direction	Paragraph 4 – A person who has been in a COVID-19 hotspot in the 14 days prior to entering Queensland must not enter Queensland unless permitted under Part 2.	NRL players, staff, and officials from the 12 nominated teams are permitted to enter Queensland if they have been in a COVID-19 hotspot in the preceding 14 days provided in the entry is in their capacity as part of NRL 2021 Season. The exemption is granted on the condition they complete 14 days of quarantine in a nominated premise and in accordance with the NRL Quarantine Accommodation and Training Facility Management Plan (NRL Hub).
	Paragraph 18 – A person listed in column 1 of schedule 1 who enters Queensland must quarantine in accordance with the requirements in column 4 of schedule 1. Paragraph 20 – A person required to quarantine under this part will be quarantined for a further period of 14 days from the end of the quarantine period if the person is not tested for	
	covID-19 when requested to do so by an emergency officer (public health), including as soon as possible after arrival at the nominated premises, between day 5 and 7 and on day 12 or 13 of the person's quarantine period.

I write in response to your request for approval of the Quarantine Accommodation & Training Facility Management Plan (the Sunshine Coast Hub Plan) for the proposed NRL Hub located at the Novotel Sunshine Coast Resort facility, 270 Ocean Drive, Twin Waters, Sunshine Coast QLD 4564 (Novotel Twin Waters Resort) and the identified training facilities located at the Novotel Twin Waters Resort and Sunshine Coast Falcons (Sunshine Coast Stadium).

I understand your request is to relocate 12 NRL teams (players, officials, and essential support staff) from declared COVID-19 hotspots in New South Wales in order to continue the 2021 NRL Season (NRL Personnel). The NRL Personnel proposed to be based at the Novotel Twin Waters Resort in accordance with the Sunshine Coast Hub Plan from 14 July 2021 are:

- Newcastle Knights
- 2. Penrith Panthers
- Sydney Roosters
- 4. Manly Warringah Sea Eagles

As you are aware, the New South Wales (NSW) Government is currently managing an outbreak of COVID-19 within NSW including locations such as Greater Sydney, Wollongong and Central Coast. Queensland has subsequently declared the Local Government Areas for these locations as hotspots under the *Declared Hotspots Direction*.

I refer to the exemption I granted to these NRL teams on 14 July 2021 to enter Queensland from a declared COVID-19 hotspot, pending the further assessment and approval of the Sunshine Coast Hub Plan.

In order to continue to facilitate this exemption and the relocation to Queensland, I have assessed and approve the Sunshine Coast Plan, subject to the following conditions:

- 1. Implement and comply with the Sunshine Coast Plan.
- For absolute clarity, this approval permits the NRL Personnel to access the identified training facilities and the match-day venues during the 14-day quarantine period.

- 3. The NRL has provided a full list of the names, residential addresses, date of birth, contact phone numbers and email addresses of NRL Personnel who will be entering Queensland as part of the Sunshine Coast Hub Plan.
 - a. Should there be any change to the identified individuals, the NRL must immediately email an updated list (including latest COVID-19 test results) to COVID-19.Compliance@health.qld.gov.au.
- 4. All players, officials or essential support staff are to continue to monitor the list of interstate exposure venues and notify COVID-19.compliance@health.qld.gov.au immediately if any of the NRL Personnel have been at these venues at the nominated day and time.
- 5. <u>All transportation</u> of the teams within Queensland is to be undertaken using an Endorsed Transport Provider.
 - a. For further information, go to https://www.qld.gov.au/health/conditions/health-alerts/coronavirus-covid-19/current-status/public-health-directions/covid-19-testing-for-quarantine-facility-workers/endorsed-transport-providers.
- 6. All NRL Personnel must complete a Queensland Border Declaration Pass prior to entering Queensland. For further information, go to https://www.qld.gov.au/border-pass.
- 7. There must be no close contact between NRL Personnel and non-quarantined persons including, but not limited to, members of the public, media, transport providers, training facility staff and Accommodation Hub staff.
 - a. Access to training facilities must have a similar set-up as the Accommodation Hub with established red and green zones and processes.
- 8. In the event that NRL Personnel are required to leave the Sunshine Coast Hub for medical treatment or testing, the ambulance service and receiving hospital are to be notified in advance that the Personnel is in quarantine. Prior to leaving the hub the public health unit is to be informed at EOC SCPHU@health.qld.gov.au.
- 9. A schedule of all training and match-day venue movements must be developed in accordance with the Accommodation Hub and these venues and if requested supplied to the public health unit at <u>EOC SCPHU@health.qld.gov.au</u>.
- 10. If any NRL Personnel or Accommodation Hub staff develops symptoms related to COVID-19, they must immediately isolate until they receive a negative COVID-19 test result.
- 11. The NRL are responsible for ensuring all NRL Personnel comply with the Sunshine Coast Hub Plan including, but not limited to:
 - a. adhering to all schedules developed and implemented by the Accommodation
 Hub staff such as mealtimes, access to transition zones and access to
 entry/exits.
 - b. ensuring meal areas, common areas, and rooms are all cleaned and disinfected between use.
 - c. cleaning of any spills and breakages.
 - d. Strict adherence to the processes for accessing and staying within:
 - i. Red zones
 - ii. Transition Zones
 - iii. Green Zones
- 12. At a minimum, there must be 24/7 security positioned at each entry and exit point to the Accommodation Hub for the duration of the quarantine period.
- 13. The NRL must work with the Accommodation Hub staff to develop and implement scheduled and staged mealtimes to ensure all NRL Personnel are not in the meal area at the same time.

- a. It is suggested this is in dedicated "seatings" of 45 minutes with adequate time scheduled between seatings to ensure the refill of food by Accommodation Hub staff can occur without any NRL Personnel in the area.
- 14. All Accommodation Hub areas and training facilities (including gymnasiums) that are accessible to the NRL Personnel are to be exclusive use.
 - a. Exclusive use means for the sole purpose of the NRL Personnel for the duration of the 14-day quarantine period. There must be no access by any other persons to these areas other than in an emergency.
- 15. For absolute clarity, the laundry of personal items conducted by NRL Personnel is only permitted in the red zone. All laundry of items outside the red zone must follow the laundry process outlined below and in the Sunshine Coast Hub Plan.
- 16. Laundry and linen must be laundered by a Laundry which meets the Australian Standards (AS/NZS 4146:2000 Laundry Practice) for commercial laundries.
- 17. No cleaning of accommodation rooms, dining areas, training facilities or any other facility or location is permitted by Accommodation Hub staff or any other cleaning contractor throughout the duration of the quarantine period, the quarantine period being up to and including the return of negative day 12 COVID-19 test results for all NRL Personnel and all Accommodation Hub staff. Cleaning must be in accordance with requirements as outlined in the Queensland Health COVID-19 cleaning, disinfection and waste management policy.
 - a. NRL Personnel must clean all equipment prior to and on completion of use at training facilities, including designated training facilities at the Accommodation Hub and any other external training facility.
- 18. If Accommodation Hub staff enter a Red Zone or there is an interaction with a NRL Personnel, then the Public Health Unit must also be notified of the incident.
- 19. NRL is responsible for ensuring any private members of the public who are owner-occupiers of units and/or property at the Novotel Twin Waters Resort are not permitted entry or access to the Accommodation Hub for the duration of the quarantine period. The Public Health Unit must be notified immediately of any breach of this condition.
- 20. Clarify that when wheelie bins are to be positioned in the Transition Zones for the collection of waste, all high touch points on the bins are to be thoroughly cleaned prior to the wheelie bins being moved by the Accommodation Hub Staff.
- 21. In the event that an individual reports symptoms, the individual is not to be sent offsite for assessment, without first consulting with the Public Health Unit.
- 22. All individuals must adhere to PPE requirements in accordance with the *Mandatory Face Masks Direction* (No. 2), effective from 22 March 2021 or its successor including:
 - i. A person at a **Queensland airport** must:
 - 1. carry a face mask at all times; and
 - 2. wear a *face mask* in all areas of a *Queensland airport*, including a passenger waiting area, at all times when at the airport; and
 - 3. wear a **face mask** where required to do so in accordance with any other Public Health Directions in effect under section 362B of the *Public Health Act 2005*.

Note: A face mask must be worn in all indoor and outdoor areas at a Queensland airport.

- 23. The Restrictions for Impacted Areas Direction (No. 8) took effect from 3 July 2021 and includes the Sunshine Coast Local Government Areas (LGA) as an impacted area. Noting the locations proposed by NRL for accommodation, training and matches are located within this LGA, all individuals must comply with requirements stated in the Restrictions for Impacted Areas Direction (No. 8) until revoked, including:
 - a. All persons who are in or have been in an impacted area at any time from 1.00am on 29 June 2021 must carry a face mask at all times; and wear a face mask covering the nose and mouth at all times if they are in an indoor space or an outdoor space. Noting that these requirements do not apply to a person in an outdoor space, including a workplace, if the person can maintain physical distance from people who are not members of their household; or to a person in an indoor space that is a residence, temporary accommodation.
 - b. For professional sporting codes, elite sport and elite athletes, occupant density requirements do not apply on the field of play, however physical distancing applies off the field of play to the extent possible.
- 24. All NRL Personnel and Accommodation Hub staff are required to comply with requirements outlined in the *Restrictions on Businesses, Activities and Undertaking* (No. 21) or its successor.
- 25. The NRL, NRL Personnel and Accommodation Hub staff must maintain ongoing communications with and follow any Direction given by the local Public Health Unit, including an Emergency Officer (General) within designated timeframes.
- 26. Strict adherence is required by all NRL Personnel in completing and submitting a *Daily Health Confirmation* in accordance with the Player & Club Protocol. Strict adherence is required by all Players and Club Officials in completing and submitting a *Daily Whereabouts Confirmation* in accordance with the Player & Club Protocol.
- 27. All teams within the NRL 2021 Season that are not within a Hub arrangement must continue to operate under the Level 4 Apollo Match-Day Protocol and the Level 4 Apollo Player and Club Protocol 2021.
- 28. NRL must provide the name and contact details of a designated NRL Personnel member responsible for actively monitoring compliance with the Sunshine Coast Hub Plan.
- 29. Any breach of the requirements to the Sunshine Coast Hub Plan, unintentional or otherwise, must be immediately reported to Sunshine Coast Public Health Unit.
- 30. All COVID-19 test results be provided to Queensland Health via @health.qld.gov.au. Test results are to be provided to Queensland Health within 8 hours of their receipt by the NRL.
- 31. Upon confirmation of Day 12 COVID-19 test result being negative for all Accommodation Hub staff and NRL Personnel, the Accommodation Hub may return to delivering normal hotel services to the NRL Personnel.
 - a. There must be no hotel services provided to any other persons until the 14-day quarantine has been completed.
- 32. The Queensland Health contact person for the Sunshine Coast Plan is:
 - a. Greg Bennett, @health.qld.gov.au.
- 33. Queensland Police Service are to be immediately informed of all breaches of quarantine to Andrew Massingham at @police.qld.gov.au
- 34. At all times physical distancing must be maintained as much as practicable.
- 35. At all times hand and respiratory hygiene are to be encouraged
- 36. An amended Sunshine Coast Hub Plan that incorporates the conditions of this approval must be provided to Compliance@health.qld.gov.au within 3 business days of this approval.

37. Where inconsistencies exist between the Sunshine Coast Hub Plan and the Chief Health Officer approved conditions, the approved conditions take precedence.

This approval does not include media and broadcast personnel who are intending to arrive in Queensland from a declared COVID-19 hotspot for the 2021 NRL Season. Any exemption request will be considered as a separate application and assessment to this approval.

Please note that this approval may be revoked or varied if Queensland, New South Wales and/or Australia experiences an increasing number of COVID-19 cases, there is an outbreak(s) of COVID-19 or further COVID-19 hotspots are declared.

1. Overview

1.1. Quarantine Management Plan

- 1.1.1. This Quarantine Management Plan is submitted to Queensland Health in support of exemptions sought to conduct quarantine accommodation and training facilities in the State of Queensland.
- 1.1.2. The actions set out in this Plan will be delivered by the NRL through its personnel and the Accor as the provider of accommodation and other facilities in accordance with this plan.

1.2. NRL Hubs

- 1.2.1. The NRL has established secure hubs in which its registered personnel may satisfy QLD Health quarantine requirements whilst training for and participating in the 2021 NRL Competition.
- 1.2.2. Each NRL Hub comprises two elements:
 - a. an Accommodation Hub at which personnel will reside;
 - b. a Training Facility at which personnel will prepare for matches.
- 1.2.3. This Quarantine Accommodation and Training Facility Management Plan sets out the procedures for management of both the Accommodation Hub and the Training Facility and the movement of personnel between them.
- 1.2.4. The Accommodation Hub to which this management plan applies is the Novotel Sunshine Coast Resort facility at Twin Waters, Sunshine Coast operated by Accor.

1.3. NRL Personnel

- 1.3.1. NRL Personnel who are granted access to the Accommodation Hub and the Training Facility are:
 - NRL Players, Club Officials, Match Officials and Medical Service personnel necessary for the delivery of the 2021 NRL Competition;
 - permitted to enter the State of Queensland pursuant to exemption from Queensland Health;
 - required to observe Quarantine conditions in accordance with their exemption, this management plan and the applicable NRL Protocol.
- These persons are referred to in this Management Plan as NRL Personnel.
- 1.3.3. Compliance with quarantine requirements form part of the NRL Apollo



Protocols which binds all NRL Personnel attending the NRL Hub.

1.4. Quarantine within the NRL Hub

- 1.4.1. All NRL Personnel will quarantine within the NRL Hub as required by the Health Order, this Management Plan and the applicable NRL Apollo Protocols.
- 1.4.2. No NRL Personnel may leave the Accommodation Hub without the prior approval of the NRL Hub Co-ordinator in consultation with NRL Apollo and Queensland Health.

1.5. Accommodation Hub Staff

- 1.5.1. Staff of the Accommodation Hub are referred to in this Management Plan as Accommodation Hub Staff and include:
 - a. administrative staff;
 - b. cleaning staff; and
 - c. security staff engaged or employed by Accor.

1.6. Monitoring, Breaches, Advice & Support

- Compliance with this Management Plan must be actively monitored by NRL and Accor.
- 1.6.2. Breaches of this Management Plan must be reported to Queensland Health (COVID-19.Compliance@health.qld.gov.au) immediately for review and escalation if necessary.
- 1.6.3. Queensland Health should be contacted for advice and support:

2. Quarantine

2.1. NRL Hub is a quarantine environment

- 2.1.1. The NRL Hub is operated as a quarantine environment in accordance with Queensland Health requirements.
- NRL Personnel must comply with quarantine requirements whilst part of the NRL Hub.
- 2.1.3. No members of the community or other persons (including health professionals) are to enter the Accommodation Hub during the quarantine period. Queensland Ambulance Service should be called for urgent care.



2.2. Hygiene, Masks & Social Distancing

- 2.2.1. All NRL Personnel will be reminded to:
 - a. Maintain physical distancing, where practical.
 - Carry personal alcohol-based hand sanitiser or ensure they have ready access to hand sanitiser;
 - Avoid touching their eyes, nose or mouth, shaking hands or making other forms of physical contact.
 - d. Cover their nose and mouth with a tissue or their arm when coughing or sneezing, and put the tissue in the bin.
 - Frequently wash their hands with soap and water for 20 seconds, or use an alcohol-based hand sanitiser.
 - f. Wear a face mask whilst in transit (e.g. airport transfers, in and around airports, on airplanes and ground transports) and suggested to wear otherwise in in the Accommodation Hub.
- 2.2.2. Masks should be changed if they are torn, damaged or soiled/moist. Personnel should always sanitise hands immediately before and after removing their mask.

2.3. Reasons to leave Quarantine

- 2.3.1. NRL Personnel may only leave the Accommodation Hub quarantine to:
 - a. Obtain essential medical care.
 - b. To avoid injury or illness or to escape a risk of harm.
 - In the event of an emergency situation.
 - As otherwise permitted by an emergency officer (public health).
 - e. Train with other NRL Personnel at the Training Facility;
 - f. Travel to and attend Match-Day in the 2021 NRL Competition.

2.4. COVID-Testing for NRL Personnel

2.4.1. Pre-Arrival Testing

a. COVID-19 testing of all NRL Personnel who have been in a COVID-19 hotspot or identified COVID-19 exposure site in the previous 14 days must be undertaken 72 hours or less prior to arrival in Queensland.



- The results of the pre-departure COVID-19 tests results must be notified to Queensland Health.
- c. Any person who receives a positive COVID-19 result prior to departure should isolate and seek medical care from their local health authority.

2.4.2. <u>Testing During Quarantine Period</u>

- a. COVID-19 testing of all NRL Personnel must be undertaken on:
 - i. Day 1,
 - ii. Day 5,
 - iii. Day 12,
 - iv. Day 16, and
 - v. if symptomatic.
- All tests results must be provided to the local Public Health Unit within a timely manner.
- 2.4.3. Upon confirmation of negative results for all NRL Personnel from Day 12 nasal swabs, the Accommodation Hub can return to delivering normal hotel services. This must first be confirmed with NRL Apollo.

2.5. Testing to Leave Quarantine

- 2.5.1. A negative COVID-19 test result is required prior to being able to leave quarantine for any reason other than:
 - a. to avoid immediate injury or illness or to escape a risk of harm; or
 - b. an emergency situation; or
 - c. as otherwise required or permitted under a direction given to the person by an emergency officer (public health).

2.6. Vaccination

2.6.1. All NRL Personnel have been strongly encouraged to be vaccinated with the appropriate COVID-19 vaccine when it is available to them, in accordance with Australia's COVID-19 vaccine national roll-out strategy.



3. Accommodation Hub

3.1. Overview

- 3.1.1. The Accommodation Hub's normal business is an accommodation and conference venue. The management of the Accommodation Hub and any associated Training Facility (where that Training Facility is on the accommodation grounds) is provided by Accor.
- It is a requirement of Queensland Health that Accor provide services in accordance with this Management Plan.
- Further details of the Accommodation Hub's procedures and plans appear in the Appendix.

3.2. Street Address

3.2.1. The Street Address of the NRL Hub Accommodation is 270 Ocean Drive, Twin Waters QLD 4564.

3.3. Site Map of Accommodation Hub
