Queensland Health

Queensland Health continues to closely monitor the COVID-19 situation in Queensland and nationally to determine whether further changes are required to health directions or other arrangements that may be in place to reduce the potential impact and risk of COVID-19 in Queensland. This includes in relation to the emergence of any new variants of COVID-19.

Queensland Health is providing further advice on escalated use of Personal Protective Equipment (PPE), given the recent community COVID-19 cases and community transmission. These precautions are intended to limit the further spread of this variant in the community and allow an assessment of risk of any further exposure in the community. This advice follows on from previous advice of 17 December 2021 that all LGAs in the state are at moderate PPE unless otherwise notified, and further advice for specific Hospital and Health Services and areas which is summarised on the Queensland Health PPE [website](#).

From 4 pm, 14 January 2022, Darling Downs Hospital and Health Service (DDHHS) and the below LGAs have been determined by the Chief Health Officer to be in the 'high' risk category:

- Toowoomba;
- Goondiwindi;
- Lockyer Valley (only postcodes 4352 and 4359);
- Southern Downs;
- Western Downs (all postcodes except 4428);
- North Burnett (only postcode 4626);
- South Burnett;
- Banana (only postcodes 4419 and 4497);
- Maranoa (only postcodes 4423 and 4427);
- Cherbourg;
- Balonne (only postcode 4497); and
- Gympie (only postcodes 4605 and 4615).

Also from 4 pm, 14 January 2022, the following towns in South West Hospital and Health Service (SWHHS) and have been determined by the Chief Health Officer to be in the 'high' risk category:

- Charleville (postcode 4470);
- Roma (postcode 4455); and
- Surat (postcode 4417).

All clinical settings in the above-listed HHSs and the LGAs listed above are to escalate use of PPE to 'high' risk category including:

- Hospitals;
- Residential Aged Care Facilities;
- Residential Disability Care Facilities;
- Prison Health Services;
- Youth detention health services;
- Community health care settings (including general practice, dentistry and home care settings); and
- Queensland Health Vaccination Clinics.

Please note that this PPE guidance is additional to, and does not replace, the CHO directives that have been formally issued, and for which compliance is mandatory. The PPE escalation will remain in place until notification that it has been rescinded by the Chief Health Officer. PPE escalation guidance documents are attached for your reference. This guidance sets out which PPE should be used in three categories of community risk – low, moderate and high. In application of the PPE guidance, the Chief Health Officer has the responsibility to determine which level of risk is applicable in a LGA or other specified geographic area. Queensland Health facilities, residential aged care facilities, and disability accommodation services are required to comply with implementation of this guidance. For entities external to Queensland Health, a decision on whether to follow the PPE protocols in the Guidance for health services will then rest with the responsible Chief Executive or equivalent for that entity, except where a Directive requires use of PPE.
