

## **Client Reference Cards**

MASS introduced MASS Reference Cards in 2022 to assist clients when applying for MASS services or when contacting MASS.

The MASS reference number ("B Number") will assist with new or repeat applications and to provide information for your local health professional (prescriber) and equipment provider.

Applicants will receive a card automatically after the approval of their next application (excluding applications for Palliative Care or Spectacles).

Existing MASS clients can also contact MASS for a MASS reference card in advance.

## **Communication Aids**

Subsidy funding is available under MASS to support eligible Queensland residents who require a communication aid.

#### **Available equipment:**

- Artificial larynges.
- Speech generating devices.
- · Voice amplification devices.
- iPads with AAC Communication Software.
- Communication software that allows a client to communicate with voice output using displays of symbols, words, a keyboard or a combination of these.
- Approved accessories for communication aids such as charger, carry case, moisture guards, keyguards and basic accessing devices/switches.
- Specialised accessories required to access a speech generating device, such as wheelchair mounting systems, switch mounts, and specialised switches/accessing devices.

**Eligible prescribers:** All speech pathologists in Queensland are eligible prescribers for MASS communication aids.

To ensure the most suitable communication aid is prescribed, you must trial the equipment adequately. Once a suitable device has been selected the Speech Pathologist will work with the client to complete the relevant application form.

# **Continence MASS-eApply Form Update**

The revised MASS-eApply Palliative Care Equipment Program (PCEP) and Continence Applications are now live on MASS-eApply – the addition of the following clinical questions will assist with processing times and prevent applications from being rejected.

#### PCEP MASS-eApply:

Three (3) questions have been added to allow prescribers to indicate if the applicant has and/or shows signs of rapid disease progression, rapid weight loss and if the applicant require a reduced supply for example, only one (1) carton due to rapid disease progression.

These additional questions assist in determining the combination of aids if required and quantities to supply this client.

#### **Continence MASS-eApply**

Questions regarding the applicant's medical conditions and incontinence were updated:

- What is the applicant's primary medical condition/disability that necessitates continence aids?
- Additional questions to specify the details of incontinence such as Stress Incontinence, Urge Incontinence, Functional Incontinence, Nocturia, Nocturnal enuresis and the reason for conduction aids that apply.

Questions regarding the application type:

- **For Initial application:** This is the client's first application requesting continence aids products from MASS.
- For Renewal applications: the client has previously received MASS Continence Aids. Questions
  were updated to allow the prescriber to comment on the applicant's current management of
  their urinary/faecal incontinence and what was identified in the review of the applicant's
  current continence status.

Questions regarding product usage and selection:

- List the continence aid(s) the applicant is currently using (if any), including full product name, size, effectiveness
- If you are requesting any change of continence product (including change in size) from
  previously supplied MASS continence products and the clinical reason(s) for the change in type
  of continence aid.
- Has the requested Continence Aids been successfully trialled? If no, provide details of why a trial was not conducted.
- An option to indicate any preference of product quantity combinations, noting that preferences may be restricted by carton amounts and amended to ensure maximum subsidy is provided.

# **Daily Living and Mobility Aids**

## Daily Living and Mobility Aids MASS-eApply form Update

As part of MASS's commitment to provide prompt and effective assistance to consumers, the Daily Living and Mobility Aids MASS-eApply form has been updated to include the following changes:

- A section added for applications received for persons under the age of 65 years, to determine MASS eligibility without the need to pend an application whilst further information is sought from the prescriber.
- A confirmation question has been added to the funding summary page to ensure that the applicant has been made aware that a copayment for cost above the approved subsidy limits may apply to the application.

These updates have been made to decrease the need to pend or hold an application where the prescriber may need to be contacted for further information. MASS encourages consumers and prescribers to provide feedback and suggestions on ways to provide a more efficient service.

### Static Bathing and Toileting Aids Trial

Did you know that applicants can now apply for assistance towards a static shower chair/stool and over toilet frame?

MASS recognises that increased frailty and declining functional ability impact directly on an individual's health, wellbeing, and comfort and places them at significant risk of avoidable/premature hospital admission.

MASS is conducting a trial which aims to address this issue by increasing available options for effective bathing and toileting aids for prescribers to better meet their client's needs at home and reduce the risk of falls.

This trial introduces a range of static shower chair/stool and static over toilet aid options, with the eligibility criteria and inclusions outlined in the <u>Static Bathing and Toileting Aids Trial Guideline Supplement</u>, which is supplementary to the <u>Application Guidelines for Bathing and Toileting Aids</u>.

# **General Guidelines Eligibility Update**

In line with the recent changes to the Aged Care funding model and introduction of the Australian National Aged Care Classification (ANACC) funding, the MASS eligibility criteria for persons who reside in a residential aged care home will be updated from 1 March 2023.

These changes will be reflected in the <u>MASS</u> <u>General Guidelines</u> from 13 March 2023.

# **Clinical Education**

This webinar aims to take a deep dive into product standards for assistive technology – what standards are, how standards are developed, the role standards can play in equipment selection, limitations of standards in product testing, buyer beware with claims of standards compliance.

Details a comparison between four (4) MASS funded artificial larynges (Romet R310, Nu-Vois III, TruTone Emote and Servox Digital XL), outlines considerations regarding the recommendation of heat moisture exchange (HME) devices and provides an update on the Queensland HME Subsidy Scheme for Laryngectomy.

Consolidate your clinical reasoning and practical skills with manual, power and tilt-in-space wheelchairs. Features include the simple mechanical assessment tool (MAT), case studies of selection and fitting, and hands-on experience with a range of wheelchairs and seating options.

## **Medical Grade Footwear**

Subsidy funding is available under MASS to support eligible Queensland residents who require medical grade prefabricated, custom made and customised medical grade footwear.

#### **Eligible prescribers:**

- Private orthopaedic surgeons
- Vascular surgeons
- Medical specialists in rheumatology, rehabilitation, geriatrics, endocrinology and neurology

Applicants require a referral to an eligible prescriber for the medical prescription and then make an appointment with a MASS approved medical grade footwear supplier for a quote to include with their application.

## **Orthoses**

Subsidy funding is available under MASS to support eligible Queensland residents who require spinal and lower limb orthoses.

#### **Available orthoses:**

- Hip knee ankle foot orthoses (HKAFO)
- Ankle foot orthoses (AFO)
- Knee Ankle Foot Orthoses (KAFO)
- Knee orthoses (KO)
- Cervical orthoses (CO)
- Thoracic-lumbo-sacral orthoses (TLSO)
- Cervico-thoraco-lumbo-sacral orthoses (CTLSO)
- approved modifications and components that are part of the current prescription.

#### **Eligible prescribers**

- Private orthopaedic surgeons
- Medical specialists in rheumatology, rehabilitation, geriatrics and neurology

Applicants require a referral to an eligible prescriber for the medical prescription and then make an appointment with a MASS approved orthotist for a quote to include with their application.

# **MASS-eApply: Online Applications**

#### What is MASS-eApply?

MASS-eApply is an online application system which allows prescribers to submit applications anytime from any location on the applicant's behalf.

MASS-eApply runs through your internet browser and is designed to work on all devices.

# **Palliative Care Equipment Program**

The MASS Palliative Care Equipment Program (PCEP) continues to provide aids and loan equipment to eligible Queenslanders to assist them to reside in their home environment during their end of life.

Types of loan equipment provided include recliner chairs, electric adjustable beds, equipment to assist with transfers where a person has reduced mobility and pressure redistribution support surfaces to assist to alleviate pain and decrease the risk of pressure injuries associated with long periods of sitting or lying down.

The PCEP team are currently developing two new resources which will be available on the PCEP website soon:

- A dedicated PCEP webpage listing Consumer, Community and Prescriber Support Organisations and Groups.
- PCEP Online Eligibility Checker.
- An information video explaining the recommended timeframes for accessing MASS funding versus PCEP funding for applicants – to be published in the near future.


# **Queensland Artificial Limb Service**

# **Spectacle Supply Scheme**

The Spectacle Supply Scheme (SSS) provides eligible Queensland residents basic prescription spectacles of single vision (near and distance) or bifocals or trifocals once every two years.

To be eligible clients must be a permanent resident of Qld and **hold in their own name** one of the following cards continuously for 6 months prior to application.

- Centrelink Pensioner Concession Card;
- Centrelink Health Care Card;
- Queensland Government Seniors Card;
- Department of Veterans' Affairs (DVA)
   Pensioner Concession Card (if not eligible for spectacles provided under the Department of Veterans' Affairs "Optical Supplies Program").
