From the Director's Desk

Welcome to the December 2023 edition of MASS Action.

On behalf of all of MASS I would like to wish you all a very Merry Christmas and a Happy New Year.

I would like to thank all our prescribers, clients, suppliers and MASS staff for the great effort over the year as good results/outcomes are only possible when you have a fantastic team supporting you.... Thank you.

As we know the majority of MASS clients are people aged over 65 years and living at home. It is good to be aware that this year saw some changes occurring in the aged care space with more to come.

Some time has passed since the Royal Commission into Aged Care Quality and Safety completed its report and made a number of recommendations on how existing Federal aged care services should change. Some of the recommendations have been implemented with others outstanding and still being progressed, particularly the Support at Home Program and the new Aged Care Act.

An Aged Care Taskforce was established and held its first meeting in June 2023. The taskforce was established to review financing of Australia's aged care system and to oversee the final design of the new in-home care program. The Taskforce drafted principles which were refined following consultation with the community. The six principles are:

 The aged care system should enable and encourage participants to remain in their home for as long as they wish and can do so.

- - Aged care funding arrangements and their outcomes should be fair, simple, transparent
 and sustainable, Government is and will continue to be the major funder of aged care;
 government funding should be focused on care costs; personal contributions should be
 focused on accommodation and everyday living costs with a sufficient safety net.
 - Government and participant contributions should be sufficient to provide quality and appropriate care delivered by a skilled workforce, allowing and encouraging innovation by the health, hospital and aged care systems.
 - There should be accountability for funding received from government and participants, how it is spent, and the quality of the services provided.
 - The residential sector should have access to sufficient, and new, capital to encourage the development of new accommodation and upgrades to existing accommodation.
 - The Taskforce will continue its consultation process and will provide its final report to government in December 2023.

It will be interesting to see how the Support at Home Program develops in the new calendar year and how it might change services available for people aged 65 years and over, in line with the aged care royal commission's recommendations.

While these changes are unfolding MASS will continue to provide its services to facilitate hospital discharge and provide subsidised supports for Queenslanders to live at home and avoid early or inappropriate residential care or hospitalisation.

Wishing you a very Happy Christmas and a safe and healthy 2024.

The MASS booth drew lots of interest from event attendees and we were able to pass on information verbally and in brochures about the range of assistive technology for which we provide subsidy funding e.g. continence aids, spectacles, mobility aids, medical grade footwear, artificial limbs, heat moisture exchange devices and laryngectomy consumables, communication aids, palliative care equipment program, daily living aids and spinal/lower limb orthoses. It was amazing to meet older people with functional impairment living in the community who had never heard of MASS! We also enjoyed engaging with other organisations who had a presence at the event. We are planning on continuing our engagement with the community at CARE Expo in 2024.

MASS Daily Living and Mobility Aids

Removal of requirement to trial basic Daily Living and Mobility Aids

In an effort to provide faster equipment delivery to consumers and prescribers, MASS Equipment Services is temporarily removing the mandatory requirement to trial basic equipment items.

The equipment types include:

- Wheeled Walking Aid
- Basic Manual Wheelchair no accessories except anti tips
- Bath Transfer Bench

- Non-Standard Bathboard
- Static chairs/Stools
- Static Over Toilet Aids

New product types funded by MASS

Static Shower Chair/Stools and Over Toilet Frames

MASS Equipment Services has completed their trial of static shower chair/stools and over toilet frames. During the trial, MASS provided over 1,000 items to clients, highlighting the need for access to these static and less complex bathing and toileting aids for consumers.

MASS Equipment Services is pleased to announce that the two new product types, static shower chair/stools and over toilet frames, have now been included permanently under the Daily Living Aids – Bathing and Toileting Aids approved equipment category.

Basic, Lightweight and Foldable Mobility Aids

MASS Equipment Services has completed their trial of basic mobility aids – manual wheelchairs, TIS manual wheelchairs and power wheelchairs. These basic mobility aids are lightweight, less complex and some are foldable or dismantlable, making it easier for lifting into cars or transporting.

During the trial, applications for the trial basic mobility aids made up 57% of mobility aids requested. This demonstrated that there was an unmet need for MASS consumers, who are more less likely to require a complex or highly customisable mobility aid and find the basic options more suited to assist them with increased mobility and safety.

These items are now available permanently under the Mobility Aids equipment categories. MASS-eApply and the MASS website will be updated with this information in the near future.

Queensland Artificial Limb Service

EXCITING NEWS!!!

Queensland Artificial Limb Service (QALS) has been granted a temporary funding increase to the annual budget from \$2.6 million to \$4.9 million per year, for four (4) years.

The funding boost will increase subsidies, during the 4 years funded, for upper and lower artificial limb components, including waterproof components (where appropriate). This increase allows QALS consumers to access a greater range of componentry and consumables for their definitive limb funded through QALS, including liners and socks.

The temporary increased funding limits are available in the <u>Guidelines for Queensland</u> Artificial Limb Service Supplement.

Everyday tasks such as showering, or situations that many of us see as a minor inconvenience, like being caught in the rain or being splashed with water, are a safety concern for people with an artificial limb if its components are not waterproof.

QALS clients are eligible to apply for funding for a definitive prosthesis (also known as an artificial limb) every three years, with more information available on the QALS website and in the <u>Guidelines for the Queensland Artificial</u> Limb Service.

QALS would like to acknowledge <u>Amputees QLD</u> (formerly Amputee and Family Support Group) for their advocacy for persons with a limb difference in Queensland and their valuable contributions in petitioning for increased funding.
