

Theograph Visualising a Patient's Care Contacts






- Person-level data means we can combine information:
 - o from different service settings eg health and human services
 - relating to an individual over time to look at e.g. readmissions or deaths after hospital discharge
 - o across public and private hospital settings
 - o from different routinely collected sources to enable improved case enumeration or to add additional details about a cohort
 - o to accurately estimate costs and assess impact of models of care





- Creating deidentified data repositories and automated reports that combine data from multiple sources – e.g. NIHSI, COVID registry, NDDA, congenital anomaly repository, Integrated Patient Journey projects, cross-episode/collection data validation reports, chronic disease dashboard
- Use for monitoring of service quality and patient safety, funding models, monitoring and evaluating services, joint Primary Health Network and Hospital and Health Service planning
- Use for predictive analytics to target patient care














Peer reviewed publications from SSB linked data
