## Scott Driscoll 'helped sack Norsefire whistleblowers'

PREMIER Campbell Newman has been further drawn into the scandal engulfing his MP as it emerges two of his Government's chief spin doctors helped massage Scott Driscoll's message.



### **Driscoll ran second group from office**

SCOTT Driscoll used his electorate office, staff and computer equipment last year to control a second organisation.

That worker, along with other complainants, found his services were no longer required at the RCAMB, which was declared insolvent last month and the 23 remaining staff stood down.

Norsefire was hired in September 2011 to provide "media, communications and fundraising services" at \$1000 a week. From about August 2012, this rose to \$2850 a week.

The services extended to Mr Driscol Mast year drafting a dismissal letter to be given to an RCAMB manager and approving the wording of redundancy notices for junior staff.

He advised on Fair Work cases, appearing in a conciliation hearing on behalf of the RCAMB against a sacked serior worker in August.

According to a person at the Fair Work hearing, Mr Driscoll "did the majority of the speaking on behalf of RCAMB".

Emails show the worker in the case had reported to the general manager in the run-up to the March 2012 election "a rumour going round that RCAMB is financing Scott Driscoll's election campaign".

Mr Driscoll was forwarded the correspondence, to which he responded on March 9: "Frankly I don't give a s--- what lies any of those gutter rats want to spin about RCA funding my campaign or me flying to Mars to have sex with a one legged mutant midget."

SCOTT Driscoll helped sack managers at a community association who raised concerns about money being paid to the Driscoll family firm, Norsefire.

Mr Driscoll even represented the taxpayer-funded association last year in a Fair Work hearing against one of the sacked staff, while an LNP MP.

Emails show a series of senior staff at the Regional Community Association Moreton Bay complained that consultancy fees charged by Norseffre, owned by Emma Driscoll and where Mr Driscoll was sole director, were excessive or unbudgeted.

The finance manager predicted in November 2011 that Mr Driscoll's invoices threatened the RCAMB's ability to pay wages.

The same worker queried the body's finances again later when her team could not obtain funds to buy food for their homeless clients. She was dismissed soon afterwards.

In May, general manager Steve Jarron warned RCAMB treasurer and close associate of Mr Driscoll's, Geoff Jamieson: "The Norsefire arrangement wasn't budgeted for".


On receiving a Norsefire invoice from Mr Driscoll for \$5300, finance manager Pubudu Madawala wrote to Mr Jarron on November 3, 2011: "I would like to bring to your attention that we have a very limited budget for consultancy fee like this (\$10,000) and we have a tight cash flow situation with forecast loss of \$120,000."

Mr Jarron was made redundant in July. Mr Madawala was dismissed weeks later.

With no general manager at RCAMB, Mr Driscoll secretly took over all its operations, directing the most senior remaining staffer by email.

The MP is under joint investigation by the Crime and Misconduct Commission and police over allegations of fraud and misconduct.

He did not respond to a request for comment



An investigation is underway into claims of official misconduct and fraud against Mr Driscoll.

The first-termer was elected in the Liberal National Party's (LNP) landslide electoral win a year ago but has faced ongoing allegations regarding improper business dealings.

Mr Driscoll denies any wrongdoing but quit the LNP at the weekend amid reports he was about to be expelled.

The CMC says the investigation follows an assessment of new information provided by an unnamed source.

A CMC spokeswoman says she is unable to speculate on how long the investigation will take.

Police Minister Jack Dempsey says he was briefed on the matter yesterday.



"Police will investigate the matter thoroughly and if there is other person involved they will certainly look into that," he said.

The ABC has tried to contact Mr Driscoll for comment.

In submitting resumes, we understand staff may not currently have access to files that would provide all relevant information.

I refer to your invitation to the Department of Health (the Department) to attend the Fair Work Commission conference on Friday 12 April 2013 to provide information about funding arrangements for service agreements with the Regional Community Association (the Association). I am advised that during the conference you requested that the Department endeavour to identify a process by which the Association's employees can receive any unpaid wages that may be owed to them.

I confirm the verbal submissions made by Ms Afme Garrahy, Acting Director, Employee Relations, at the conference, that:

- a) The Department is one of several government agencies that have service agreements with the Association:
- b) Under the service agreements being administered by the Department the Association is responsible for payment of all wages and entitlements to employees;
- c) There is no employment relationship between the Department and the Association's employees;
- d) The terms of the service agreements provide for suspension of funding in certain circumstances;
- e) By letter dated 27 March 2013, jointly signed by the Department and the Department of Communities, Child Safety and Disability Services, the Association was advised that an independent financial and compliance audit had been commissioned as provided for under the terms of the service agreements; and
- f) By letter dated 28 March 2013, the Department gave notice to the Association, as provided for under the terms of the service agreements, that payment of funding was suspended pending the outcome of the audit.

The Department remains committed to its decision to suspend payment of funding to the Association pending the outcome of the independent audit. As the Department does not employ the Association's staff, there is no process available by which the Department can pay any unpaid wages to those staff.



NEWMAN Government bureaucrats knew seven months ago of LNP MP Scott Driscoll's inappropriate involvement in a taxpayer-funded community association that gave his wife's consulting company Norsefire tens of thousands of dollars in consulting fees.

The allegations raise questions about the Newman Government's willingness to investigate the serious matters raised about the behaviour of Mr Driscoll, who has been suspended from the LNP.

The Courier-Mail reported last month that Mr Driscoll had secret control of the Regional Community Association Moreton Bay while an MP, directing day-to-day operations, including its finances and dealings with federal and state governments, until February.

This newspaper can now reveal a Department of Communities official first flagged concerns in late August about a proposed meeting at Mr Driscoll's electorate office to "go through the contract and signing" of a community program.

The official wrote on August 27 to RCAMB services manager Tracy Slater, expressing concerns that "as Mr Driscoll is the sitting Member of Parliament for Redcliffe", direction would have to be sought from the official's Executive Officer.

On September 6 the official wrote: "I am yet to receive the confirmation to accept the meeting with Mr Scott Driscoll MP at his office".


The same day, Mr Slater forwarded the email exchange to Mr Driscoll at his scott@norsefire address.

The exchanges between Mr Slater and Mr Driscoll are included above.

On December 14, two Communities department officials met RCAMB senior staff and its president, Bruce Mills. One official asked about the "communication process" used with a consulting firm to which management of the association had been "outsourced".

The officials failed to ask for the firm's name, despite one of them having been copied in on a complaint three weeks earlier naming Norsefire and detailing the involvement at RCAMB of Mr Driscoll and his wife.

RCAMB was letter asked to provide the firm's name by December 28 and the communication details by February 28.

The Courier-Mail understands the information was never supplied.

Separately, a whistleblower made a detailed complaint to Communities after an RCAMB annual meeting on December 19 that Mr Driscoll chaired while office bearers were elected. The whistleblower complained of people being excluded from the meeting, a lack of transparency about financial information, and the identity of companies said to have replaced the role of chief executive.

The Courier-Mail has obtained the department's February 14 response to the whistleblower.

North Coast regional director Patricia Occelli wrote: "Please be reassured that the North Coast Region is investigating your allegations in order to ensure compliance of responsibilities within their Service Agreement and within the Act.

"Therefore, it has been determined that no further correspondence from North Coast Region is required regarding your complaint and it will be closed, effective 15 February 2013."

Four days later, The Courier Mail began publishing a series of exposes of Mr Driscoll's business activities.


The paper revealed Tast/month that Norsefire, where Mr Driscoll was sole director, earned \$2850 a week from RCAMB for "secretariat management services" from about August 2012. Mrs Driscoll was also on the payroll from late last year as HR administrative officer.

Premier Campbell Newman told Parliament on March 19 that the Government had "properly investigated" complaints against Mr Driscoll.

The departments involved now refuse to answer questions about officials' initial concerns, whistleblower complaints and attempts to investigate, all of which have been uncovered by *The Courier-Mail* investigation.

They also decline to say whether Communities Minister Tracy Davis was briefed or had any

involvement.

# Group's audit more check-up than autopsy

AN AUDIT under way at the Regional Community Association Moreton Bay is not the "forensic" probe touted by government spin doctors but a relatively routine look at the organisation's finances.

The Courier-Mail reported last month that Queensland Health and the federal Department of Families, Housing, Community Services and Indigenous Affairs had jointly commissioned an independent audit of the RCAMB following allegations of mismanagement and financial irregularities involving

Member for Redcliffe Scott Driscoll, who has been suspended by the LNP.


The federal department described it as a "forensic" audit. A spokeswoman for PriceWaterhouseCoopers, however, told *The Courier-Mail*: "We haven't been appointed to undertake a forensic audit. Forensic audit means a very different thing."

According to the website of PwC, the accounting firm hired to do the work, most of its forensic services team "are certified fraud examiners and hold Certificate III in Investigative Services

Certificate IV in Government Investigation and Fraud Control and Commercial Agents and Private Inquiry (CAP) licences."

Queensland Health said of the audit: "Should any evidence of criminal activity or misconduct arise, the auditors would refer such findings or evidence to the Department of Health immediately and relevant authorities (such as the Queensland Police Service or Crime and Misconduct Commission) for further investigation."

# Government under fire over Driscolllinked community group funding

The Regional Community Association Moreton Bay (RCAMB) says it is owed significant sums of Queensland Government funding withheld after complaints of mismanagement.

Redcliffe MP Scott Driscoll has been accused of controlling the group and funnelling money to his wife's consultancy business.

He has denied any wrongdoing.

RCAMB says it will have to appoint a liquidator to wind up the organisation.

Queensland Communities Minister Tracy Davis says services will instead be provided by the Pine Rivers Neighbourhood Centre.

However, the Moreton Bay group says the Pine Rivers group is also in financial trouble.

But Ms Davis says she is not aware of that.

"That's not my understanding and certainly not my brief from the department," she said.

"The money will be used through the Pine Rivers Neighbourhood Centre to deliver the services that were previously delivered through RCAMB."

But Queensland Opposition Leader Annastacia Palaszczuk says the State Government has not done enough to sort out RCAMB's financial problems.

Ms Palaszczuk says Ms Davis and her department have had several options for investigating the group.

"They were able to issue a compliance notice and they were also able to use the powers under the Act for an authorised officer to go in and sort this




issue out," Ms Palaszczuk said.

"For two weeks the Minister did absolutely nothing."

The Board of the Regional Community Association Moreton Bay (RCAMB) who are all voluntary, provide the following statement in the public interest.

The Board of the RCAMB regrets to advise that it has been forced to make an application to wind up the organisation and appoint a liquidator to ensure all debts are collected and all creditors are paid accordingly, along with the staff of the RCAMB. Unfortunately the application cannot be heard until after Easter which meant that the staff had to be stood down so the organization did not incur any further liabilities.

The primary basis of this action is due to non-payment of substantial debts owed by various entities to RCAMB, including other community organisations as well as state and federal government agencies. The organization is owed approximately \$295,000 with another \$200,000 payable in April. RCAMB only requires approximately \$68,000 to meet all current creditors and therefore would be in a very kealthy sash position if the Government would release funds that are owed.

\$216,000 of the \$295,000 is owed to RCAMB by Department of Health (Mental Health) for services delivered by RCAMB from July to December last year with another \$108,000 becoming due next week for the March quarter 2013. This represents \$324,000 that RCAMB has outlaid delivering these programs without any reimbursement from Department of Health. Despite repeated efforts by the Board to have some of this money released so we could pay the staff their wages of \$22,000 on Thursday, no funds have been forthcoming.

As the Board of a charity, which operates in a responsible manner with regard to finances and governance, the RCAMB does not maintain excessive cash reserves and is reliant on debts owed to it to be paid in a responsible and timely fashion. This has not been the case, despite the RCAMB providing all services and outcomes required of it and its staff.

The RCAMB Board has been advised that certain funds are now being retained pending an Independent Audit of the organisation because of "anonymous complaints" from unknown individuals. Any such complaints are entirely baseless, given the Board has adopted responsible governance practices, ensured the delivery of agreed and target outcomes for our dients and has presented fully audited financials at all required times and as recently as at the RCAMB AGM late December 2012. No valid issues exist on any of these matters and "anonymous complaints" to the contrary are a complete nonsense. The Board welcomes the Independent Audit and has stated it will work with the Auditor and provide any assistance required.

Over the last 12 months the RCAMB Board and organisation has endured false, misleading and malicious attacks from individuals who were previously associated with the organisation. These attacks have come in the form of direct threats made to Board members and staff, malicious and false claims in certain media as well as grossly aggressive commentary via anonymous social media and Twitter accounts. Also the organization has been caught up in a Political witch-hunt because of its association with the Local Member of Parliament. The direct result of this is now the closure of a great local community organisation.

This is a tragedy on the basis that our performance delivery and our financial position is extremely strong. Our sole issue is cash flow, based on non-payment of accounts of debtors to the RCAMB.

One of the travesties of Justice in this whole matter is that the Minister of Communities has directed, that an organization that owes \$46,000 to RCAMB be appointed to take over the services and staff of RCAMB. RCAMB has delivered services on behalf of Pine Rivers Neighborhood Centre and they have not paid RCAMB for these services even though we believe they have received payment from Government. RCAMB can only presume that Pine Rivers Neighborhood Centre is in financial difficulty because of non-payment of the funds to RCAMB.

The RCAMB Board sincerely thanks the fine staff of the organisation for their efforts over the long term to assist our highly valued clients. The Board will work with the liquidators in the best way we can to ensure debtors are brought to account and creditors and staff are able to access their entitlements. We will also liaise with relevant agencies to ensure our clients suffer as little disruption to services as possible.

The RCAMB ask that people respect the difficult and challenging circumstances being worked through by all concerned.

Scott Driscoll drama is just not croquet

A CLOSE political associate of Redcliffe MP Scott Driscoll, who sacked 23 staff members of the community group at the centre of the scandal surrounding the MP last week, told the shocked workers the controversy was hurting his croquet game.

Geoff Jamieson, election campaign treasurer for Mr Driscoll and a board member of the Regional Community Association Moreton Bay, told the staff "you are all stood down" and then berated them for demanding information about their future.

"You've asked for it so I'm giving it to you," he told astonished workers.

"You asked me for the facts but you didn't let me explain any of the things, so that's what you wanted, OK?"

He had earlier explained that he had resigned as treasurer of RCAMB "some time in February" and then returned so the board - which Mr Oriscoll stacked with his political associates - could continue to function.

"Before I came back on as treasurer, went right through all the accounts to satisfy myself that the organisation was one, solvent, and two, that it had sufficient funds to carry on the programs, and three, that there was no financial impropriety or irregularities in any of the accounting," Mr Jamieson told staff.

"I went right through that with the information that was available to me before I left because what happened is, the day I did that I had to go off, because I play croquet and I was representing the state of Queensland in Adelaide for the ... er, umm, south-east croquet ... er ... state team.

"So I went away to Adelaide for two weeks ...

"When you're playing for your state you have to concentrate and I had to block a lot of this out until I got back."

Shocked staff demanded Mr Jamieson "get to the facts", at which point he told them they were all stood down.

The Courier-Mail revealed last month that Mr Driscoll has been controlling RCAMB from behind the scenes and funneling \$120,000 in consulting fees to his wife's company, Norsefire. Queensland Health has hired an accounting firm to audit the RCAMB but investigators have yet to visit the premises.

The financial collapse of RCAMB last week has raised concerns for the association's 500 vulnerable clients, who rely on its programs.

Speaking to The Sunday Mail after Thursday's meeting, Mr Jamieson distanced himself from Mr



Driscoll, accusing him of having "run for the hills".

"I am not here for one second to protect Scott Driscoll," he said. "He is no friend of mine."

He said he tried to avoid standing down staff by appealing to the State Government to lift its funding freeze, but was told money would not be available until after the audit.

Mr Driscoll has repeatedly refused to respond to media questions about his involvement in RCAMB.

Workers at a community association secretly controlled by Redcliffe MP Scott Driscoll have been stood down

STAFF at a taxpayer-funded community association secretly controlled by Redcliffe MP Scott Driscoll have been stood down.

Twenty-three staff members of the Redcliffe Community Association Moreton Bay were told by the service provider's three remaining board members at a meeting this afternoon their jobs had been terminated.

Staff member and volunteer Len Thomas said staff were due to have received their fortnightly pay yesterday but have been told there is no money.

"We have some pretty distressed and distraught staff down here, " said federal member for Petrie Yvette d'Ath.

Ms d'Ath said she had notified state Communities Minister Tracy Davis.

She said staff at the meeting had been told the association was insolvent.

**Earlier it was reported,** that members of RCAMB, which Scott Driscoll secretly controlled to the benefit of his wife's firm, want the MP's associates removed from the board.

By yesterday, five had put their names to a call for an emergency meeting on April 8, in a bid to take over the body and ensure it continues to provide emergency social services to its 500 or so clients in the community.

The Courier-Mail yesterday met staff of the taxpayer-funded Regional Community Association Moreton Bay who said they feared for their jobs and the future of essential services for clients with mental health problems, the homeless and victims of domestic violence.

The staff said they were shocked and disgusted that no one from the State Covernment had visited them, despite the widely publicised problems at the centre, and they had not been able to tell employees whether they would be paid this week.

No one had visited or inspected documents in recent weeks, they said except board members.

Staff said they had been surprised to hear a statement in Parliament by Communities Minister Tracy Davis that her department was "working hard" with RCAMB.

"We want (Premier Campbell) Newman and the minister to come and see us," said one staffer, who did not want to be named. "Where are the CMC?" another asked. "We're waiting for them."

Len Thomas, a former police officer and RCAMB member who is backing the move to overhaul the board, said there were members "ready to step up" and take over governance of the association. "We can change the constitution if necessary" he said. "(The Department of) Communities needs to act today to guarantee continuity."

Staff said acting RCAMB president Brian Rosell and treasurer Geoff Jamieson, both close political associates of Mr Driscoll, had not been returning their calls.

Mr Thomas gave The Courier-Mail a letter from the Office of Fair Trading showing that its records had Mr Roselt as president, effective March 11, but made no mention of Mr Jamieson. Instead, Terry Rogers is shown as treasurer.


This is despite Mr Rogers having been forced off the RCAMB board by Mr Driscoll last year after he asked questions about the ownership of Norsefire, Mr Driscoll's wife Emma's company, which has earned \$120,000 in consulting fees from RCAMB over the past 12 months.

Mr Jamieson, who was Mr Driscoll's election campaign treasurer, this week told The Courier-Mail there was "no impropriety" and "no irregularities" at RCAMB. "We've got a short-term cash-flow problem as a result of the media reports about Scott Driscoll," he said.

Mr Jamieson said he had only found out this week that Emma Driscoll had been on the payroll.

The Department of Hearth last week hired PriceWaterhouseCoopers to carry out a forensic audit of RCAMB.

## Call for CMC to investigate allegations against MP

The powers of the Integrity Commissioner are "almost negligible" and the crime watchdog should investigate Liberal National Party MP Scott Driscoll, according to a former chair of the Parliamentary Crime and Misconduct Committee.

LNP defector Alex Douglas has called on Premier Campbell Newman to refer Mr Driscoll to the Crime and Misconduct Commission over allegations about impropriety in his business dealings.

The Redcliffe MP has denied any wrongdoing and referred himself to the parliamentary Integrity Commissioner on Monday.

But former PCMC chairman Dr Douglas says the powers of the commissioner are "extremely limited".

"I wouldn't say they're absent but they're almost negligible, is probably a fair word," he told ABC 612 Brisbane.

"... the CMC is charged with doing investigations on [allegations of] major misconduct and this is what that is."

Dr Douglas said Mr Newman would be the appropriate person to refer Mr Driscoll to the CMC.

The allegations centre around Mr Driscoll's role with the Regional Community Association of Moreton Bay and the Queensland Retail Traders and Shopkeepers Association since becoming an MP.

The RCAMB paid \$120,000 to Mr Driscoll's company Norsefire for consultancy work including \$13,000 for eight days work.

On Tuesday, News Limited chaimed Mr Driscoll had used his electorate office as the "secret base" for lobby group the Queensland Retail Traders and Shopkeepers Association.

Questions asked by the Integrity Commissioner David Solomon would not be made public and neither would Mr Driscoll's responses.

Dr Douglas sand the commissioner would not be able to conduct a proper investigation into Mr Driscoll and the CMC were the only viable option.

"Because it's only fair to have someone dealt with in an appropriate manner, people should be considered innocent until proven guilty but you've got to be able to investigate them in a proper manner," he said.

"The only investigation mechanism that is appropriate in this circumstance is the CMC."

Mr Driscoll last month told the media he'd had "no operational involvement" in the QRTSA since he was elected to parliament.

## MP Driscoll responds to impropriety claims in Parliament

Posted 20 minutes ago

Controversial Redcliffe MP Scott Driscoll has made a statement to Queensland Parliament responding to claims about family business interests.

Mr Driscoll has denied claims he continued his role with a retail lobby group after being elected and that his wife received populic funding as a consultant to a local community group.

Premier Campbell Newman says the Crime and Misconduct Commission (CMC) investigated the Regional Community Association of Moreton Bay last year, and found no evidence of wrongdoing.

Mr Driscoll yesterday referred himself to the integrity commissioner, but says he is confident there has been no wrongdoing.

However, he will have to correct his wife's interest in a consulting company on the Parliamentary register.

"While her involvement in this company is already declared, I'll be updating a section of her interest register to reflect the fact that she receives income from that company of more than \$500," Mr Driscoll said.

"I regret this oversight and will rectify this today."

## Other allegations

Mr Driscoll is also accused of continuing his role as boss of an industry lobby group while serving as an MP.

The Courier-Mail newspaper claims Mr Driscoll has been using his electorate office to run the Queensland Retail Traders and Shopkeepers Association.



The newspaper says he installed dedicated phone lines and computers, and used staff on parliamentary salaries to assist the not-for-profit group.

Mr Driscoll has told Parliament extra phone lines were installed for community groups to use.

"I can confirm I wrote to the clerk of Parliament last year advising him of my intention to establish a community hub access point for wifi and communications, which was utilised by various community groups," he said.

"The clerk advised me that there was no issue with this and for a period of a number of months last year, this service had been available to a number of community groups.

"I will also always provide honest advice and support to any small business operator, community group, or individual that seeks my help."

## Investigation

Mr Newman says the other allegations are now being investigated.

"There were allegations about the operation of that organisation back in 2011," he said.

"That's the claim I had before me and can advise the House that it's my understanding that the previous government, and perhaps those opposite who were in Cabinet, maybe should have done something.

"My understanding is they didn't do anything.

Mr Newman says the LNP Government referred the matter to the Crime and Misconduct Commission last year in November.

He says the CMC found no evidence of misconduct.


Mr Newman has told Parliament he has had a similar experience to Mr Driscoll.

Queensland Liberal National Party MP for Redcliffe Scott Driscoll link to fund scandal and claims of secret control of taxpayer-funded community association

A STATE Liberal National Party MP has been secretly controlling a taxpayer-funded community association that helps the homeless and other people in need, funneling tens of thousands of dollars in consultancy fees to his wife's company.

The Courier-Mail has established that Redcliffe MP Scott Driscoll has been directing the operations of the Regional Community Association of Moreton Bay, a provider of frontline social services to his electorate, from behind the scenes since becoming an MP.

Mr Driscoll cemented control - with the help of friendly RCAMB members - installing political mates on the board in 2012, getting his wife a job on the payroll and having dissenting staff removed and forcing a troublesome board member to resign.

Former RCAMB staffers have told *The Courier-Mail* that money was so tight last year they could not access funds to buy food for homeless clients of the RCAMB, which received about \$1.6

million in public funding and donations in 2012.

It has been established that Mr Driscoll has had secret day-to-day control of the management of the RCAMB for at least the past 12 months, while Norsefire, a company owned by his wife Emma and where he was sole director until she took over on February 25, received almost \$120,000 for consultancy work, only some of which was actually performed.

Emails, invoices and other documents show Norsefire charged \$1000 a week until the middle of last year for "media communications strategy and management" and subsequently \$2600 a week for "secretariat management fees".

From August 2012 there is no evidence of Norsefire having any employees to conduct any work on behalf of RCAMB.

Even prior to this, RCAMB staff say there was little evidence of any benefit from the "press liaison" work they understood Norsefire had been contracted to do.

Mrs Driscoll, a florist, was from late last year on the payroll as "HR admin officer".

Mr Driscoll wrote her job description, which includes "formal qualification requirement: nil".

On February 28, a day after the Department of Communities asked RCAMB, formerly known as the RCA, for information about payments to consulting companies, Emma Driscoll sent an email to a colleague at the association asking for help to "delete what is in the drop box that was on my laptop which I have of course left at RCA".

"Is there a way we/you can do a complete sweep of that computer both files/trash/word docs etc ... so there is nothing left on there?" she asks.

All the members of the RCAMB board during 2012 except one worked on Mr Driscoll's election campaign, including his campaign director Ben Scott, his campaign treasurer Geoff Jamieson and

former local Federal LNP chairman Brian Roselt. Its president until last month was Bruce Mills, another supporter.

The Courier-Mail understands Mr Mills held about half of the votes of the RCAMB's 20 members as proxies, which with the votes of Mr Jamieson, Mr Scott and Mr Roselt gave Mr Driscoll's political mates control of the board.

The other member of the board is understood to be a "client" of the RCAMB's mental health program.

When former RCAMB Treasurer Terry Rogers, himself a former state MP, questioned Norsefire's involvement in the association in March 2012, Mr Driscoll wrote to Mr Mills and Mr Scott saying:

"The buck stops with an elected MP or Minister to make any required disclosures not Terry Rogers ...

"I personally suggest it's time his position on this board was considered for him and action taken pretty quickly right now".

Mr Rogers was forced to resign from the board shortly afterwards.

Mr Driscoll has disclosed his directorship of Norsefire but has publicly distanced himself, saying it is "100 per cent owned by my wife".

He has only ever described himself as "patron" of the RCAMB.

But emails show he micromanaged the body, giving instructions on everything from financial audits and how to respond to demands for information from bureaucrats to which airconditioning company should be used.

In January he even banned staff from participating in free health checks provided by Medicare Local.

"The fact paid RCA staff at large are being encouraged or allowed to avail themselves of funded services while the staff are meant to be working in essentially a government funded role could understandably create a catastrophic PR disaster," Mr. Driscoll wrote to services manager Tracey Slater on January 17.


Emails also show Mr Driscoll presented Norsefire invoices to RCAMB and chased up payments.

Federal and State Governments are investigating the RCAMB over allegations of mismanagement and financial irregularities following complaints by staff.

Mr Driscoll did not respond to a request for comment. Mr Mills did not respond to questions. Mrs Driscoll could not be reached.

Mr Driscoll won the seat of Redcliffe at the LNP's landslide election victory last year.

Redcliffe had long been considered a Labor stronghold but the force of the LNP victory meant such seats were swept to the conservatives. Mr Driscoll has received strong support from Premier Campbell Newman in Parliament in recent weeks under scrutiny from the Labor Opposition.
